# Suggested amendments to the FCWC by-laws to be voted on at the April general meeting:

Italicized words in brackets would be deleted; Red Bold words would be the potential revisions.

#### Item 1:

Article III Section 3. Fiscal Year: The fiscal year of the club shall begin on [the first day of September and shall end on the thirty-first day of August] June 1 and go through May 31.

Article IV Section 1. Club Year: The club year shall begin on [September 1 and go through August 31] June 1 and go through May 31.

#### Item 2:

Article V Section 4. Terms of Office:

[With the exception of the Treasurer, officers may serve for a term of two (2) years, or until their successors are elected]. All elected board positions will be for a term of one (1) year. Their term of office shall begin at the end of the May general meeting. No member shall hold more than one office at a time. Members holding an elective office shall be eligible to serve two consecutive terms in the same board position [with the exception of the President] if selected by the nominating committee. If she is able, the treasurer shall serve for two years in order to effectively manage the club's finances.

#### Item 3:

Article VI Section 1. The President: The President shall preside at all meetings of the club and the Board of Directors. With approval of the Board of Directors, she shall appoint [a Photographer, a Parliamentarian and] coordinators for events as needed.
