### **Creating Tablescapes by Kimbra Privitt**

We had such a great time at Barbara Desco's home for our March meeting on tablescapes. Thank you Barbara! Kimbra Privitt, floral manager for Tom Thumb, addressed the steps to creating a wonderful tablescape. First, gather all the items you need for your formal tablescape, including dinnerware, flatware, glasses, linens and centerpiece. Then, decide on the theme (Easter) and color (purple). Start your tablescape by placing the linens and arranging each formal place setting. Add the centerpiece and decorate outwardly as much as you desire.

Barbara's table centerpiece was a beautiful silver candelabrum with purple candles flanked by two large whimsical wooden bunnies. Napkins were folded and tied with purple ribbon into which a yellow daffodil was inserted and then placed on top of the dinnerware. At each place setting were added small jars filled with jelly beans sitting on Easter grasses. Transforming the table into a cozy English garden were mint julep containers; one filled with all yellow daffodils, another of just pink tulips, and the final one only blue and purple hydrangeas. Glass covered silver cake stands holding Easter grasses and colorful eggs were also added along with a container of rye grass holding more Easter eggs. A silver urn with flowering branches and assorted flowers took center stage on the buffet. From plastic eggs to fresh cut flowers, Barbara's table embodied Easter at its springtime finest.
